Railway Journeys

MOTION

Recommendation:

That this town council writes to:

- Secretary of State for Transport (Chris Grayling) and Minister for Rail (Paul Maynard)
- Chairs of Great Western Railways and South West Rail
- The Cabinet Member for Highways & Transport (Philip Whitehead) & transport portfolio holder for Wiltshire Council (Horace Prickett)

To complain about relative overcharging for residents of Westbury and Dilton Marsh for journeys to Salisbury and the lack of stops preventing meaningful outward and return journeys from Dilton Marsh Halt (particularly at commuting times) in all directions.

- 1. Complain that more trains should stop at Dilton Marsh Station**
- 2. Complain about unfair charging to Westbury residents and unfair journeys offered from Dilton Marsh Train Station.**
- 3. When writing to South West Trains to ask why the 12:50 Waterloo to Pen Mill train does not stop at Dilton Marsh when it has more than enough stoppage time at Westbury.**

P.4422 NOTICE of MOTION from CLLR JENKINS dated 9th January 2017

Railway bridge, Station Road

MOTION

Wiltshire County Council as the local Highways Authority placed a 7.5 ton weight restriction on the bridge over the railway line on Station Road, Westbury in circa 2008 during the Westbury Bypass public enquiry.

The reason for the weight restriction is the serious weakening of the structure of the bridge which is Victorian in construction.

Wiltshire County Council was succeeded by Wiltshire Council in 2009 who is now the local Highways Authority.

Station Road forms the principle route way linking the Westbury Trading Estates with locations south of Westbury.

Community Volunteers have organised a lorry watch scheme in response to frequent violations of the restrictions. Some prosecutions of violators have been successfully brought.

Lorry Watch has been successful as a deterrent to some but the number and frequency of violators persist because there are an insufficient number of volunteers to man a constant watch.

Wiltshire Council estimates that strengthening repairs to the bridge could be in excess of £1 - £1.5m.

Recommendation:

Given all the above, this Council resolves:

1. To write to Wiltshire Council as a matter of urgency and request that the bridge works are included in its 2017/18 capital budget.
2. That the council should include most of the above in developing its case for the bridge's inclusion in capital programme and any other idea suggested by the HP&D committee.

RESOLVED TO APPROVE THE ABOVE RECOMMENDATION AND THAT THE CLERK WRITES TO BOTH WILTSHIRE COUNCIL AND NETWORK RAIL AS IT IS A SHARED RESPONSIBILITY.

The group decided to take up the option to carry out an online benchmarking exercise. The cost is £100. The group discussed the best options for advertising the survey.

The group received an update on the possibilities for hiring recent graduate/post graduate with relevant urban planning qualification to facilitate the work on the Neighbourhood Plan. The group are considering how to incorporate some minimal time from an experienced supervisor to guide this person.

The group met on 16th January 2017 and will give an update at the next meeting.
